19	items as described in the application is required by the CRA and the City; and
20	WHEREAS, this ILA describes the funding and maintenance responsibilities for both
21	the City and CRA and meets the requirements of the grant conditions as outlined in the
22	CRA's Inerlocal Agreement with the SWA; and
23	WHEREAS, the City Commission of the City of Boynton Beach, upon
24	recommendation of staff and the CRA Board, deems it to be in the best interests of the
25	residents and citizens of the City of Boynton Beach to approve the Interlocal Agreement
26	between the City of Boynton Beach and the Boynton Beach Community Redevelopment

27	Agency regarding the maintenance of the improvement projects as described in the SWA'		
28	Blighted and Distressed Property Clean-up and Beautification Grant Pro	ogram.
