**RESOLUTION NO. R16-\_\_**

**A RESOLUTION OF THE CITY OF BOYNTON BEACH, FLORIDA, APPROVING AND AUTHORIZING THE MAYOR TO SIGN AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF BOYNTON BEACH AND THE TOWN OF BRINY BREEZES FOR THE PROVISION OF FIRE RESCUE AND EMERGENCY MEDICAL SERVICES; AND PROVIDING FOR AN EFFECTIVE DATE.**

13           **WHEREAS**, the Town of Briny Breezes (“Town”) desires the City of Boynton Beach  
14 (“City”) to provide fire rescue and emergency medical services to the Town; and

15           **WHEREAS**, the City has the equipment, personnel and resources to extend its  
16 protection service area to provide fire rescue and emergency medical services to the Town;  
17 and

18           **WHEREAS**, the City will maintain the standards of fire and rescue services to the  
19 Town consistent with the services currently provided by the City within its municipal limits;  
20 and

21           **WHEREAS**, the City has mutual aid agreements with Palm Beach County Fire  
22 Rescue Delray Beach Fire Rescue and Boca Raton Fire Rescue; and

23           **WHEREAS**, the City will provide fire and rescue services to the Town in  
24 conformance with City Code Ordinances and City fire rescue department protocols; and

25           **WHEREAS**, the City will provide fire and rescue personnel to ensure that the Town  
26 will receive the same standard of fire and rescue services; and

27           **WHEREAS**, the City Commission of the City of Boynton Beach, upon  
28 recommendation of staff deems it to be in the best interests of the residents and citizens of the  
City of Boynton Beach to approve and authorize the Mayor to sign the Interlocal Agreement

29 between the City of Boynton Beach and the Town of Briny Breezes for Fire Rescue and  
30 Emergency Medical Services.

31 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF**  
32 **THE CITY OF BOYNTON BEACH, PALM BEACH COUNTY, FLORIDA, AS**  
33 **FOLLOWS:**

34 **Section 1.** Each Whereas clause set forth above is true and correct and  
35 incorporated herein by this reference.

36 **Section 2.** The City Commission of the City of Boynton Beach hereby approves and  
37 authorizes the Mayor to sign the Interlocal Agreement between the City of Boynton Beach  
38 and the Town of Briny Breezes for Fire Rescue and Emergency Medical Services, a copy of  
39 the Interlocal Agreement is attached hereto as Exhibit "A".

40 **Section 3.** This Resolution shall become effective immediately upon its adoption.
