**A RESOLUTION OF THE CITY OF BOYNTON BEACH,
FLORIDA, AUTHORIZING AND DIRECTING THE
CITY MANAGER TO SIGN AN AGREEMENT FOR
WATER SERVICE OUTSIDE THE CITY LIMITS AND
COVENANT FOR ANNEXATION BETWEEN THE CITY
OF BOYNTON BEACH AND ANGELA EDYTHE ERB
AND ROSS A. CERANCI; PROVIDING AN EFFECTIVE
DATE.**

14 **WHEREAS**, the subject property is located outside of the City limits, but within our
15 water and sewer service area, at 7089 Lawrence Road, Boynton Beach, FL 33436 (Parcel
16 Control Number 00-42-45-12-02-001-0040); and

17 **WHEREAS**, the parcel covered by this agreement is located in the unincorporated
18 Palm Beach County portion of the City's utility service area; and

19 **WHEREAS**, the property historically receives water from a well and the owner
20 requests that the City provide potable water in the future; and

21 **WHEREAS**, no additional construction is required by the City to serve this property.

22 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF
23 THE CITY OF BOYNTON BEACH, FLORIDA, THAT:**

24 Section 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as
25 being true and correct and are hereby made a specific part of this Resolution upon adoption
26 hereof.

27 Section 2. The City Commission hereby authorizes and directs the City Manager
28 to sign a Water Service Agreement between the City of Boynton Beach, Florida and Angela
29 Edythe Erb and Ross A. Caranci, a copy of which is attached hereto as Exhibit "A".

Section 3. This Resolution shall become effective immediately upon passage.
