17	requirements issued by the Florida Department of Environmental Protection (FDEP), and the
18	countywide coordination of the permit requirements; and
19	WHEREAS, the permit regulates stormwater discharges from the municipalities, specia
20	districts, and other agencies in Palm Beach County, and will enable us to continue to coordinate
21	our stormwater activities with other agencies countywide; and
22	WHEREAS, the City Commission, upon recommendation of staff, deems it to be in the
23	best interests of the citizens and residents of the City of Boynton Beach to enter into this NPDES
24	Fourth Cycle Permit Interlocal Agreement;
25	NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE
26	CITY OF BOYNTON BEACH, FLORIDA, THAT:
